Dear Friends of the Philharmonic,

Welcome to the 2016-17 Philharmonic season, our 30th Anniversary season. We appreciate your attendance and support, whether you are a season ticketholder, an occasional attendee, or if this is your first time to experience the vibrant music of your Columbus Indiana Philharmonic.

Another great season has been planned for you--from our first concert featuring Sean Chen, to the Salute! concert, where the community gathers to celebrate and honor those who have served our great country. We are so appreciative of the excellent quality our musicians bring to us with each concert and for the efforts of the many volunteers, the Notables, the staff and our financial sponsors, all of whom make our 30th anniversary season possible.

From its beginning in 1970, the Phil has become a critical part of our community, with its mission to involve the community musically in a variety of ways. From our early years, the Phil has grown from 15 dedicated board members, 1 part-time staff, 50 musicians, 20 Notables, 50 season subscribers, with a budget of \$60,000, to this 30th anniversary season, with 25 engaged community board members, 13 full and part-time staff members, 76 musicians, 52 Notables, 570 season subscribers, a budget of \$802,000, and a robust youth music education program.

The Philharmonic continues to enjoy the great musical leadership of David Bowden, Music Director and Conductor. We are also appreciative of the extraordinary administrative leadership of Margaret Powers, Executive Director, and the fine staff that serves our Philharmonic. But none of what they do is possible without your support! Thank you for being here and for your continued support of our other ventures, as well, including the Cabaret Series, Lobsterfest, and youth music events.

In our 29th year, the Phil was very fortunate to be the recipient of two exceptional gifts, allowing us to continue on the course of musical excellence. The contribution from Enkei America of an exquisite Shigeru Kawai Concert Grand Piano and then in March of 2016 the gift of the Philharmonic building by Helen and Bob Haddad will allow the continuing legacy of the Philharmonic in this community.



TREASURER'S REPORT

Fiscal Year 2015-2016 submitted by Terry Trautman

For the fiscal year the Philharmonic recorded a record profit in the amount of \$369,000. This was made possible by two major contributions that will greatly enhance the musical productions and programs offered by the Philharmonic for years to come. The first is the contribution of the Shigeru Kawai Concert Grand Piano given by Enkei America, Inc. The second is the contribution by Bob and Helen Haddad to the Philharmonic of the building that houses the Philharmonic offices. We are indeed grateful for these gifts and look forward to sharing both with the community as we go forward.

The operating results exclusive of these major contributions were steady and our cash balance has increased by \$28,000 from last year.

For the past year we budgeted and achieved operating revenue in excess of \$817,000. Going forward with great anticipation coupled with new challenges, the board approved a budgeted revenue goal of \$883,000, an increase of 10.2%. Again, we are exceedingly thankful for the continued support of the greater community as we endeavor to bring music that is enjoyable to our constituency and encourages the music education of our youth.

Several years ago, I communicated in our annual report that things were going very well at the Philharmonic. In fact, I stated that we seemed to be experiencing the beginnings of a renaissance with all the pieces coming into place for a significant increase in our educational activities, new artistic directions, and a surge of service to our community. Today we are witnessing that organizational expansion and flourishing in full measure.



Musicians in the Schools

Philharmonic musicians visit schools, playing their instruments, discussing their lives as musicians and answering questions from curious children. This is often just the introduction children need to pique their interest in learning to play an instrument.

Philharmonic Youth Orchestra (PYO)

PYO provides an encouraging and challenging orchestral setting for middle and high school musicians. Philharmonic musicians conduct sectional rehearsals, coaching them on playing techniques and musical interpretations. PYO performs side-by-side with Philharmonic musicians, hosts an Invitational attended by orchestras from surrounding schools and plays for a variety of organizations each year.
