

## **Columbus Pro Musica, Inc. BourbonBlast Raffle Rules**

Columbus Pro Musica, Inc., d/b/a Columbus Indiana Philharmonic, is a 501(c)(3) entity whose mission is to make music. Funds raised through this Raffle will assist with music education and programming.

### **Raffle Rules and Eligibility**

#### **1. Eligibility.**

Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations, and further agrees to release Columbus Pro Musica, Inc., its directors, officers and employees from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person residing in a country or state where the Raffle is not prohibited. Entrants must be 21 years of age or older and a legal resident of the state of Indiana. Proof of age and residence will be required at time of receiving prize package.

#### **2. Certificate Purchase**

The cost to purchase a single entry for the Raffle is \$20.00 (U.S. funds only) and is not tax deductible. There is no maximum limit to the number of tickets that will be sold. Any entrant may purchase more than one entry. Payment can be made by cash, check or debit card. If an entrant's payment is dishonored by the bank for any reason, such entrant's entry will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Completed entry forms must be in the possession of Columbus Pro Musica, Inc. by Noon on Wednesday, May 12, 2021. All entry forms will be handled and recorded on a first come, first served basis. Any entry forms and payment, including payments previously dishonored, received after closure of the Raffle will be returned to the entrant. Upon receipt of a completed entry form and valid payment, an entry with assigned number will be issued. A letter acknowledging receipt of valid payment and notifying the entrant of their entry number will be emailed to the entrant or mailed via U.S. Postal Service if an email address is not available.

#### **3. Prize**

The prize is one of six packages with each package consisting of 10 bottles of various spirits. The winner must pick up the package within 30 days of the drawing or the winner forfeits all claims thereto. Winner is responsible to pick up package at the Helen Haddad Hall in Columbus, Indiana.
